EXTENSION POLICY

A copy of the federal extension must be attached to the return at the time of filing. Taxpayers who have not requested an extension for filing the federal tax return may be granted an extension for filing of the City of Huber Heights tax return by submitting a written request to the City of Huber Heights Tax department by the original due date of the return. An extension of time to file is not an extension of time to pay taxes due. Penalty and interest charges will apply to all payments received after April 18, 2023.
