APPLICATION FOR A PERMIT TO WORK IN THE RIGHT-OF-WAY

I (We) agree to place a bond with the City of Huber Heights and that the following conditions will be met:

1. To replace street surface WITHIN TWENTY-FOUR (24) HOURS after installation.
2. That TRAFFIC WILL BE MAINTAINED AT ALL TIMES, UNLESS PERMISSION IS GRANTED by the City of Huber Heights to close the street.
3. That the DISTURBANCE to the street surface and shoulders WILL BE KEPT AT A MINIMUM and that trenches will be backfilled with gravel and tamped, to that SETTLEMENT of the material WILL BE MINIMIZED. If settlement does occur, additional suitable material will be put into place and compacted.
4. That the street surface and adjacent right-of-way at the TRENCH WILL BE REPLACED WITH MATERIAL of the type THAT WAS REMOVED and that the NEW SURFACE WILL CONFORM WITH THE GRADE of the undisturbed surface.
5. That LIGHTS, SIGNS, BARRICADES AND, IF NECESSARY, FLAGMEN AND WATCHMEN, WILL BE PLACED ON THE JOB for the protection of traffic at ALL TIMES, day and night, during the time the WORK IS BEING DONE.
6. NONE of the above work WILL BE STARTED in a City of Huber Heights right-of-way PRIOR TO APPROVAL of this application.
7. The CITY REQUIRES the following INSPECTIONS with a twenty-four(24) hour notice:
Sidewalk * Curb * Drive Approach Telephone No. 937-237-5810

(A) FORMS Inspection - After forms are placed, BEFORE concrete is poured.

(B) FINAL Inspection - 10-14 Days AFTER WORK IS COMPLETE and area is COMPLETELY RESTORED.

8. ALL WORK must be done IN ACCORDANCE WITH the City of Huber Heights STANDARDS & SPECIFICATIONS.

This PERMIT WILL EXPIRE Sixty (60) Days from the Date of Issuance. ALL WORK AUTHORIZED BY THIS PERMIT MUST BE COMPLETED according to the City Plans & Specifications AND MUST HAVE BEEN APPROVED by the City Inspector BY THAT TIME.

Anyone who starts or continues to work under this permit after the above expiration date will be guilty of a minor misdemeanor, will be named as a criminal defendant in court, and will be subject to a criminal fine of up to \$ 100.00.
